A PLANT COLLECTION OF 17,651 TAXA AND 7,645 SPECIES WAS MAINTAINED WITH 5,152 NEW PLANT ACCESSIONS ADDED TO THE COLLECTIONS DURING 2016. 196,000 INDIVIDUAL PLANTS WERE PRODUCED AND DISPLAYED IN THE SEASONAL DISPLAYS. 76 ACRES OF DISPLAY GARDENS AND 2,400 ACRES AT SHAW NATURE RESERVE WERE MAINTAINED. THE GARDEN PROVIDED PLANT AND GARDENING INFORMATION TO 4.3 MILLION USERS VIA ITS WEBSITE.
