Meeting Summary

Committee chair Mary Parker began the meeting by reviewing the 2013 metrics and the Petal Challenge new-member flower graphic. The Corporate Partners Program has added six new members thus far in 2013, and four of those were through the outreach of the Corporate Council. Mary thanked and congratulated Rick Lodewyck and Jason Thein for their outreach to new partners Anders CPAs + Advisors and SWT Design, respectively.

The extra Corporate Partners event held on Tuesday evening, July 16, in conjunction with members-only walking hours and the new Desert Show was quite a success with 302 corporate guests and 16 new memberships. Unfortunately, due to a computer error, the Garden was unable to capture which Corporate Partner companies were represented at the event. The Garden IT team is working to ensure the issue is fixed and will not impact future events.

The next Corporate Partners Day will be held at Shaw Nature Reserve on Sunday, September 15, and will not use the same IT system.

The bulk of the meeting focused on reviewing the color-coded list of current Corporate Partners, active prospects, and "wishlist" prospects divided by industry. This visual tool illustrate which industries have strong representation within the Corporate Partners Program as well as those industries where we have room to grow.
