

# **Shaw Series Winter Symposium 2025: Speaker Bios**

## Rashonda Alexander, Community Development Administration - City of St. Louis

Rashonda Alexander serves as Director of Compliance for the Community Development Administration managing the allocation and oversight of varying federal and local funding sources including CDBG, CDBG-CV, CDBG-DR, SLFRF, Economic Development Tax, and the EPA Brownfields Assessment. She first joined the City working as a Policy Writer with the St. Louis Agency on Training and Employment and transitioned to CDA charged with managing the CHOICE Neighborhood Initiative and the Environmental Review process. She authored the written strategy/internal policy required by HUD for electronic submission of environmental reviews into the HUD Environmental Review Online System (HEROS) and drafted the administration's tuition reimbursement policy, advocating for benefits to support internal professional development and equity. Prior to local government administration, Ms. Alexander worked in higher education, where she led the Student Affairs' division transition from commuter-based to residential-focused student activities, drafted the first iteration of the residence hall handbook and policy, and student organization leadership training. She also served as adjunct faculty in the business school teaching various courses surrounding business administration and management. Rashonda possesses formal and advanced degrees in business administration, is a licensed Missouri notary, realtor, cosmetologist, instructor, MWBE, and SBIR recipient of the Department of Energy's EERE- Bioenergy sector award.

## **Brittany Kelly, Stormwater STL**

Brittany joined Stormwater STL in March 2020 after graduating from the horticulture program at Saint Louis Community College – Meramec Campus. In her time with the company, Brittany has worked in various areas of post-construction stormwater management including inspections, maintenance, and managing the native plant stewardship program. Under her care, the native plant stewardship program has more than doubled in size, with more than 70 biodetention basins currently under the care of Stormwater STL. In addition to caring for the

native vegetation in biodetention basins, Brittany also performs routine inspections of stormwater BMPs and leads the permeable pavement maintenance program.

#### Mark Kuelker, Metropolitan St. Louis Sewer District

## **Shelley Morris, Greenwood Cemetery Preservation Association**

Shelley Morris, in her roles as Board Secretary and Historian for the Greenwood Cemetery Preservation Association since 2016, has overseen a remarkable transformation. The onceabandoned cemetery, with overgrown trees, soil erosion, impassable roads, and invasive brush, has been turned into a beautiful green space. This achievement was made possible through collaborations with organizations such as Engineers Without Borders, AmeriCorps, Missouri Department of Conservation, Missouri Botanical Gardens, Missouri Coalition for the Environment, and Missouri Stream Team. Greenwood Cemetery is now on the National Register of Historic Places and the National Underground Railroad Network to Freedom, a testament to the organization's mission to restore the cemetery grounds and make it an educational resource for the community. Before her current position, Shelley's 38-year career as a Project Estimator and Energy Services Consultant at Ameren Missouri prepared her well for the challenges she now faces. Her recent involvement as a board member with the Associated Cemeteries of Missouri and her membership in the Delta Sigma Theta Sorority further demonstrate her commitment to community service.

## Joe Oelke, Beyond Housing

Joe Oelke, a Certified Arborist, holds credentials as an Urban Forestry Professional and Tree Risk Assessor from the International Society of Arboriculture. He leads Beyond Housing's Forestry and Community Conservation Department.
